**Subject: Eligibility criteria for appearing in Continuous Professional Development Test-II.**

Sir/Madam,

The Continuous Professional Development (CPD) Scheme consisting of three tests was introduced in Indian Audit & Accounts Department in the year 2013 to keep the SAS passed Gazetted Gr. B officers abreast with the latest developments in the field of auditing on a continuous basis and to test them periodically on basics as well as advanced topics in auditing. It was decided by the Competent Authority to extend the CPD Scheme to DAOs Grade-I and Senior Divisional Accounts Officers w.e.f CPD-I (Main) Examination 2016.

2. The detailed instructions have been circulated vide this office Circulars No. 32/Staff (App1)-2012 dated 06.09.2012 and office Circular No.34- Staff (App 1)/2015 dated 09.10.2015.

3. As per the scheme, CPD-II test can be taken by Sr. AO/Sr DAO/AO/AAO/DAO Grade-I after elapse of four years from qualifying their first CPD test.

4. References have been received from field offices forwarding therewith applications received from officials who have passed CPD-I (Supplementary) Test, held in March 2014. These officials have requested for considering their candidature for ensuing CPD-II (Main) Examination 2017, scheduled to be held in September 2017.

5. Since, officials who have qualified the CPD-I (Supplementary) Examination held in March 2014 will not be completing eligibility criteria of 04 years service, therefore, they are not eligible for appearing in CPD-II (Main) Examination 2017 scheduled to be held in September 2017.

6. It is further clarified that CPD-II (Main) Examination 2017 can be negotiated by such officials who have qualified the CPD-I (Main) Examination held in August 2013.
