In continuation of offer of appointment for the post of Divisional Accountant issued by this office on 13.03.2020, it is stated that as per HQ's letter No.418-Staff (App.II)74-2020 (Vol-II) dated 24.04.2020 (copy enclosed), the lockdown period will not be counted for the purpose of adherence of the prescribed time limit in the provisional offer of appointment for reporting of the candidates and the due date for reporting/joining will get postponed by the number of lockdown days.

The Govt. of India has since issued guidelines for lifting of lockdown (except in containment zones) intrastate/interstate movement of persons with effect from 01.06.2020. As such, if you are willing to accept the offer of appointment issued by this office, you may reports in this office for joining in terms of DoPT OM dated 05.06.2020 (lockdown period of 23.03.2020 to 05.06.2020 not taken into consideration for calculating the time limit prescribed in the offer of appointment).

Subject: Counting of the limitation period for reporting of joining a post by the direct recruits and measures to be taken at the time of joining of the candidates in view of the Coronavirus (COVID – 19) – regarding.

Sir/Madam,

References are being received from field offices regarding the joining/extension of joining time of nominated candidates to various Group 'B' & 'C' posts in IA&AD through the Combined Graduate Level Examination 2017, in wake of the lockdown due to COVID -19 epidemic in the country.

2. The issues raised by the offices have been considered and it is clarified that the lockdown period will not be counted for the purpose of adherence of the prescribed time limit in the provisional offer of appointment for reporting/joining of the candidates. The due date for reporting/joining will get postponed by the number of lockdown days. The joining of the candidates during the lockdown period may be deferred and the candidates may be advised to report their joining after the lock down is lifted by the Central/State government.
3. The Cadre Controlling Authorities are requested to take appropriate action on the matter accordingly.
